Headquarters Porch Reroofing

On recent visits to Kentucky Camp you may have noticed that the roof of the Headquarters Porch was letting in sunlight and rain through some wide cracks! Alas, the past 16 years of southern Arizona weather have taken its toll on the wooden shingles. Originally installed when the modern porch was installed in 2001, the shingles have served their purpose well but were in dire need of replacement.

Fortunately, we had relatively new shingles leftover from the reroofing work completed in 2010 as a result of the American Recovery and Reinvestment Act. In that project, all shingles at the site were replaced with the exception of the Headquarters porch. (The porch shingles were still in fair shape at that time.)

So, on November 7-10 of last year, we conducted a work week at Kentucky Camp to replace the shingles on the porch of the Headquarters

building with the "leftover" shingles from the 2010 project.

Recreation Site Fees

The Coronado National Forest is restructuring its Developed Recreation Program. Developed recreation sites are areas that have amenities such as drinking water systems, fire rings, tables, food storage lockers, grills, benches, garbage bins, restrooms, signs, etc. While Kentucky Camp does have some of these amenities, they are maintained with the efforts and funding of the Friends of Kentucky Camp and the Forest Service Cabin Rental program.

Costs to operate, maintain, and replace developed recreation facilities exceed current and projected revenue. Revenue to manage developed recreation sites includes both federal budget allocations and fees, which represent about 50% of the allocated budget for the developed recreation program.

The Coronado National Forest is looking at a combination of four strategies for restructuring: Elimination developed sites; Transfer management to partners/concessionaires; Increased fees; Increased fee sites.

Of the Coronado's 204 developed recreation sites, 78 are fee sites. An additional 31 developed sites with similar amenities as the 78 fee sites are potential fee program recreation sites. This includes Kentucky Camp.

Between September 2016 and September 2017, the CNF plans to engage partners and members of the public to craft effective strategies to close the gap between the costs and revenues of the current and future developed recreation program.

Based on public comment, the CNF will propose actions to restructure the developed recreation program.

The Friends of Kentucky Camp board does not believe that Kentucky Camp should be considered as eligible for Recreation Site fee assessment because the site does not receive Recreation Site Funding and is supported through the efforts and funding of the Friends of Kentucky Camp and the Cabin Rental Program.




